1. Program Registration Fee is included in Partnering Fee of \$500.00 paid by the organization. Please mail the completed Registration Form to the following address. Last date for receipt of Registration Form is **January 15, 2020.**

2. Preferences will be given to programs from bona fide cultural organizations.-No request for a solo program from an individual performer will be entertained.

3. NABC 2020 Performing Arts Committee is the sole decision maker regarding selection of any particular program.

4. NABC 2020 reserves the right to reject any proposed performance if deemed inappropriate by the Committee or for any other reason whatsoever.

5. Every effort will be made to maintain the program schedule. However, NABC 2020 Performing Arts Committee reserves the right to change the scheduled timing and the venue (stage, auditorium, etc.) of the program without advance notice to the performers.

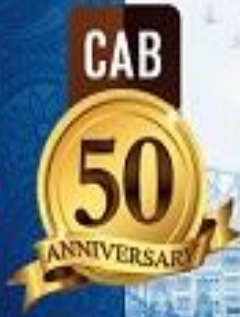
6. Maximum time allotted for any program will be 22 minutes or less and time allotted for each program shall be strictly enforced. The Representative/ Group Leader/Director of the performance must submit a video taping of the entire program from beginning to end to establish that the performance duration is within the allotted time. The Performing Arts Committee reserves the right to take any and all appropriate actions to stop the program in case the program overruns the slated time limit. **ALL PARTICIPANTS ARE REQUESTED TO NOTE THIS ITEM AND STRICTLY LIMIT THEIR PERFORMANCE TO THE TIME ALLOTTED.**

7. All individuals participating in a program must be individually registered for the NABC 2020. Registration badge will be a requirement for access to the stage/green room area.

8. No Organization will be allowed to assign or share the slated time slot to or with other Organization(s).

**9. No individual will be allowed to participate in more than one event (performance and/or activity). Performing Arts Committee, NABC 2020 will not entertain any request for schedule change due to conflict that might be created by an individual planning to perform in two or more programs.**

10. Performing Arts Committee will not be responsible for making arrangements for an audience-packed auditorium. Presence of sufficient number of spectators in the auditorium is beyond the control of the organizers. Performers must understand that the audiences have



the right to select the program they want to attend. No request from the Performers/Directors for rescheduling the program due the insufficient spectator (in the performers’ judgment), will be entertained.

11. The program organizer/performers must not engage in any activity (such as display, lecture, recitation, play, dance, drama, dance drama, vocal and /or instrumental music and/or any other form of presentations) which could be construed as an attempt to convey any message of a political party/propaganda, any religious thought or faith, or any activity that may create racial or communal controversy or ill feeling.

12. The program organizer/performers must not engage in any activity (such as display, lecture, recitation, play, dance, drama, dance drama, vocal and/or instrumental music and/or any other form of presentations) which in the sole opinion of NABC 2020 is considered “obscene” and/or “vulgar”.

13. The “stage preparation time” and “stage clean up time” are the Management’s time and will be utilized at the discretion of the Performing Arts Management team. No compromise will be made regarding the use of stage preparation and clean up time, in full or part thereof, by the performers.

14. The program organizers/performers must not engage in any activity during their performance which could create any form of environmental, chemical, and/or fire hazard including but not limited to open flame, storage of combustible and hazardous material, tampering or interfering with electrical lines, etc.

15. The performing organizations and all individual performers participating in the performances must have adequate insurance against all types of injury and/or loss due to accidents, errors, omissions or commission of acts by the NABC 2020 organizers, volunteers, employees and officers. The performing organization and its individual performers will have to exempt the NABC 2020 organizers, its volunteers, employees and officers from any responsibilities for any such injury and/or loss.

16. Failure to comply with any of the above Terms and Conditions may lead to cancellation of the program or stopping the performance during its presentation.

**17. Each group should have minimum 25 registrations for NABC2020 to be approved for stage performance.**

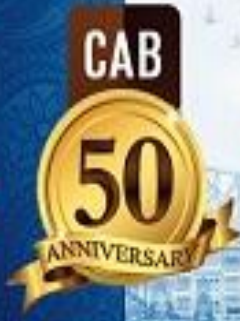
